- ➤ Broiler House Energy Audits Josh continues to perform energy audits through Rural Development's REAP program.
- ➤ WAE About sixteen hours/week are being spent working WAE.
- ➤ North Georgia Tree Planting Initiative (ARRA Project)
 - ❖ All site plans have been approved and bid packets are available on the Council's website at chestchattrcd.org
 - ❖ Bids are due by COB Friday, November 19
- ➤ Mud Creek 319(h) Phase 2
 - ❖ The GAEPD contract is still pending
 - ❖ Josh has begun contacting steering committee members
- ➤ Soque River 319(h)
 - ❖ Water sampling throughout the watershed has resumed
 - ❖ Josh assisted with a Soils Day at South Habersham Middle School on November 1, 2010 attended by approximately 250 students
 - ❖ Another Soils Day is scheduled for North Habersham Middle School on November 16
- ➤ Georgia CIG Payment is pending for the October 7 invoice. UGA continues to monitor energy usage on the poultry houses that have installed the recommended improvements.

- > USF&WS
 - Payment is still pending for the invoice submitted for the Shaw Park Demonstration Project in Cobb County
 - Lumpkin County has expressed an interest in a bridge replacement project in the Etowah River Watershed, but there is nothing new to report at this time
- Farmers' Market EBT
 - * Yearly totals are pending for the farmers' markets in Union and Rabun counties
- American Forests Global ReLeaf Northeast GA
 - ❖ The application was not funded; we can re-apply in January, 2011
 - ❖ Larry added there may be funds available through the US Forest Service re-establish the long leaf pine
- Georgia Agritourism
 - ❖ A statewide conference was held November 3rd − 5th at the Dillard House. Approximately 125 people registered for the conference and 175 attended the legislative dinner
- ➤ Legacy Tree Project
 - The project summary was distributed
 - This information will be presented at the upcoming Georgia Mountains RC meeting
 - ❖ UGA Entomology and Extension recently endorsed the project

- ➤ Master Equine Management Course The first steering committee meeting is scheduled for November 29 at 2:00 p.m. at the Habersham EMC building

 - ❖ FY-2009 APIG invoice in the amount of \$19,700 has been submitted and payment is pending
 - ❖ The Council is co-hosting a Farmbill training workshop November 30 at the Franklin County Ag Center. While this is targeting the Vietnamese population (an interpreter will be on-site), the workshop is open to all interested parties.
