- Approve Agenda

- Secretary Report
 - Approve Minutes
 - April 13, 2020 these minutes were approved at the May 4 meeting but another discrepancy was later discovered. Mike Ward was shown as voting for himself as vice-chair. Corrected the minutes to show he abstained from voting on is appointment. Motion to approve by Bill Flowers, seconded by George Bennett, passed unanimously.
 - **May 04, 2020** Bill Flowers noted a miscount in the vote on approving the March 9, 2020 minutes. The vote was 4 to 1 not 5 to 1. Bill Flowers opposed. Mike Ward made

motion to accept the minutes as amended, second by George Bennett, passed unanimously.

- New Business
 - Greg Teague, President Croy Engineering
 - Runway Lighting Rehabilitation Project Mr. Teague discovered \$18K invoice was unpaid from runway lighting rehabilitation project. This is to update existing lighting on the runway. Discussed options to pay invoice if/when lighting rehab project is executed. According to Mr Teague, funds were paid to the authority from GDOT in July 2019 to reimburse the invoice but was never paid to Croy. No authority member remembers invoice or reimbursement. Mr. Teague agrees they made an error by not providing this updated amount when we requested total unpaid charges for the phase 1 local share. Motion by Mike Ward that we pay the \$18K invoice after the project is approved in our capital improvement plan by GDOT, second by George Bennett. Approved unanimously.
 - Discuss and Schedule OEC (Owner, Engineer, Contractor) Meeting Croy has on-site contract administration for phase 2. Will meet on regular intervals to discuss progress on project and understand invoices. Snell will submit schedule of values to Croy for approval and then it will be sent to the Authority for approval. Meeting to be scheduled on a regular basis. No action necessary on this item.
