The Bills being considered that are of most interest to Avita are: Allowing APRNs to prescribe schedule II drugs in an emergency, the allowance to extend Telehealth options permanently, to allow DBHDD to coordinate all audits of BH provider to prevent duplication, grant permission for meetings to continue in a teleconference format during non-emergencies, expands Medicaid coverage for pregnant women, provides a Medicaid expansion program allowing greater coverage, allows for participation in an interstate licensure compact for social workers, professional counselors and LMFT SPADD and GACSB joined efforts to lobby for a rate increase for services provided by DSPs, our Board member Kent Woerner was one of those who testified We are pleased to see the number of Covid cases decrease in Georgia, but we are still taking precautions to keep numbers at Avita down Construction progress continues at the BHCC Gov.
