Approximately twenty additional guests and partners attended.

Angela Whidby, Chestatee-Chattahoochee RC&D Executive Board member, called the meeting to order at 10:00 a.m. This was followed by the Pledge of Allegiance.

Mike Berg, Dawson County Commission Chairman, welcomed the group to Dawson County. Attendees were given an opportunity to introduce themselves and state what organization they represented.

Angela presented both Larry Nix and Edsel Nix with a \$50 gift certificate to Longhorns as a show of appreciation for their service on the Executive Board.

Jerry Boling, NRCS/RC&D Coordinator, retired, provided a presentation on the November 1977 failure of the Toccoa Falls Dam. This tragedy resulted in the loss of 38 lives and the subsequent passage of legislation to prevent this type of catastrophe in the future.

The following proposed revision to the by-laws was discussed: Article III of Membership of Section 2, add "One additional representative may be appointed by the Council from each of the sponsoring organization; provide, however, that the sponsoring organization may substitute another individual to fill the third representative seat from the sponsoring organization within 30 days following written notice of the appointment." A motion was made by Leslie George, 2nd by Katheryn Granberg to adopt the revision as presented. The motion carried. There being no further comments, the business meeting was adjourned.

Following an invocation offered by Edsel Nix, a delicious meal was enjoyed compliments of Dawson County Commission.
