Meeting Minutes April 19, 2022 Regular Meeting 2:00 PM 18A FBO

- 2:00 PM Call to Order
- Establishment of Quorum
 - Attendees Eddie Addison (Chair), Mike Ward (Vice-Chair), Kevin McCraney (Sec/Treas), Mark Brown, Jonathon "Bo" Rowland, Woodson "Woody" McFarlin.
 - Guests Drew Dotson (Hartwell Sun), Rebecca Collins (Croy)
- Prayer-Mike Ward voiced a prayer.
- Pledge of Allegiance Mike Ward led us in the Pledge of Allegiance
- Approve Agenda
 - Mike Ward made a motion to approve the agenda, seconded by Woody McFarlin.
 Passed unanimously.

Secretary Report

 Approve minutes from March 3, 2021 – Bo Rowland made a motion to approve, seconded by Woody McFarlin, approved unanimously.

Treasurer Update

- Operating/Fuel account reports from January and February 2022 were shared with the authority. March 2022 financials were not available at the time of the meeting.
- The fuel account is down to approximately \$25,000 due to both tanks being filled recently. Fuel sales will replenish the account.
- Payoff on the hangar loan is approximately \$19,000
- Phase 2 matching funds all accounts have been settled on the parallel taxiway project and we have \$740.60 remaining in the funds from the Hart and Franklin IBAs. \$370.30 was offered back to both IBAs and we were told to use the funds for the betterment of the airport.

Old Business

Airport Mowing, IGA (intergovernmental agreement) with Franklin County – Mike
 Ward gave us an update on the mowing done by Franklin County. He is checking with

- Nick Johnson (Franklin County) to confirm price before clearing on the West end of the runway starts.
- Eddie Addison suggested adding spraying around the runway lights to Troy Wiley's lawn maintenance to reduce the risk of damage from the mowers. Addison will check with Troy Wiley to see if this can be added.
- Eddie Addison discussed the upcoming airport inspection on May 5 by Alan Hood (GDOT). Several trees will need to be removed to clear approaches. Addison and Ward are attempting to contact affected property owners.
- FYE 2021 Audit by Jay Green Addison discussed the audit including property value accruals. It was noted there was no discrepancy in the fuel accounting. This is primarily due to the new fuel sumping system. According to Mark Brown, 99% of the fuel is recovered with this process. Requirements for single point audit were discussed. Rebecca Collins (Croy) will follow up to see if this audit meets the requirements. Bo Rowland made the motion we search for a new accountant for future audits, seconded by Mike Ward. Passed unanimously.
- Obstruction Removal waiting on report from May 5 inspection to identify obstructions.
- Eddie Addison mentioned the Franklin County IBA has posted an ad to fill the vacancy they have on the Franklin Hart Airport Authority.

New Business

- Shelter for Courtesy Car The courtesy car and fuel truck have been received from Titan. The need for a shelter was discussed but tabled to determine the location for placement at the airport.
- Executive Session Motion to enter executive session to discuss real estate and possible litigation by Bo Rowland, seconded by Woody McFarlin, passed unanimously at 2:50 PM.
- Resume Regular Session motion to reenter regular session by Mike Ward, seconded by Bo Rowland, passed unanimously at approximately 3:55 PM.
- Action items from Executive Session
 - Discussed having timber cruised on potential property acquisition. Several members will check on price.
 - Bo Rowland recommended we give Asa Brown a reminder about the requirement to house a flyable aircraft in his hangar. None is hangered there currently.
- Adjourn Motion by Bo Rowland to adjourn the meeting, seconded by Woody McFarlin, passed unanimously at 4:06 PM.
