Hart County Board of Commissioners met May 25, 2021 at 6:00 p.m. at the Hart County Administrative & Emergency Services Center.

Chairman Marshall Sayer presided with Commissioners Frankie Teasley, Michael Bennett, Ricky Carter and Joey Dorsey in attendance.

1. Prayer

Prayer was offered by Chairman Sayer.

2. Pledge of Allegiance

3. Call to Order

Chairman Sayer called the meeting to order.

4. Welcome

Chairman Sayer welcomed those in attendance.

5. Approve Agenda

Commissioner Dorsey moved to amend and approve the agenda to include items 13 g) Liberty Hill Subdivision; h) Sheriff Request credit for experience; and 15) Litigation. Commissioner Teasley provided a second to the motion. The motion carried 5-0.

# 11. Commissioners' Reports

Commissioner Dorsey offered condolences to the Ashworth family; a volunteer fire fighter lost his home due to a fire; recommended anyone to watch the video produced in Hart County for National EMS week; and the Open Records/Open Meetings training session had a very low turnout.

#### 12. Old Business

Michele Wetherbee requested the Board to consider changing all paragraphs in the ordinance referring to Dog Control Officer be changed to Animal Control Officer.

Chairman Sayer called for the vote. The motion carried 4-1 (Commissioner Carter opposed).

#### c) Tax Assessor Board Appointment

Commissioner Carter moved to appoint Elaine Evans to serve the remaining term on the Board of Assessors. Commissioner Dorsey provided a second to the motion. The motion carried 5-0 (Term expires 12/31/2023).
