Chairman Marshall Sayer presided with Commissioners Michael Bennett and Frankie Teasley in attendance; Commissioner Jeff Brown via zoom; Commissioner Joey Dorsey via telephone.

1. Prayer

Prayer was offered by Commissioner Bennett.

2. Pledge of Allegiance

Everyone stood in observance of the Pledge of Allegiance.

3. Call to Order

Chairman Sayer called the meeting to order.

4. Welcome

Chairman Sayer welcomed those in attendance.

Commissioner Dorsey addressed damages to roads due to GDOT's detour while replacing a bridge on State Highway 29; his desire to avoid the same issues from developing when GDOT starts construction on other bridges in the county that are slated to be replaced.
