The Hart County Board of Commissioners met October 10, 2017 at 5:30 p.m. at the Hart County Administrative & Emergency Services Center.

Chairman Joey Dorsey presided with Commissioner R C Oglesby, Frankie Teasley, Marshall Sayer and Ricky Carter in attendance.

1. Prayer

Prayer was offered by Commissioner Marshall Sayer.

2. Pledge of Allegiance

Everyone stood in observance of the Pledge of Allegiance.

3. Call to Order

Chairman Dorsey called the meeting to order.

4. Welcome

Chairman Dorsey welcomed those in attendance.

5. Approve Agenda

Commissioner Oglesby moved to approve the meeting agenda. Commissioner Teasley provided a second to the motion. The motion carried 5-0.

7. Remarks By Invited Guests, Committees, Authorities Recreation Board presentation to Bill Granger

Commissioner Carter moved to adopt a resolution recognizing Mr. Bill Granger for service on the Recreation Advisory Board. Commissioner Sayer provided a second to the motion. The motion carried 5-0

8. Reports By Constitutional Officers and Department Heads

County Attorney Walter Gordon commended Mr. Granger for his service to the community while serving on the Recreation Advisory Board.

9. County Administrator's Report

County Administrator Terrell Partain reported October is breast cancer awareness month.

10. Chairman's Report SPLOST V

Chairman Dorsey presented an overview of the various projects accomplished since 2006 derived from SPLOST funding including, roads/bridges, economic development (new industries, expansions of local industries, job creation plus \$347.8 million in new investment) county water (installed 130 miles of water lines, two storage tanks, fire hydrants); fire department (countywide ISO rating of 4, purchased 8 pumpers, purchased ladder truck, replaced 8 tanker trucks, replaced 12 jeep brush trucks, replaced 2 SCBA trucks, built/equipped Station 2, Station 9; process of building Station 10, updated turnout gear), recreation (purchased land for Elberton Hwy Complex, graded/built 4 baseball/softball fields, graded/built 2 football/soccer fields, graded/paved 2 parking lots, built 2 concession stands, score towers, acquired playground equipment, 4 batting cages, community gardens, dog park).

He presented a proposed projects listing for the upcoming six year SPLOST referendum for November 11, 2017; categories \$3.6 million roads/bridges; \$3.2 million Economic Development; \$3.2 million County Water; \$1.4 million County Fire; \$1.24 million for public safety equipment/capital improvements; \$500,000 for Recreation capital improvements; \$2,304 million City of Hartwell; \$358,400 City of Royston; \$185,600 City of Bowersville and \$37,100 City of Canon.

11. Commissioners' Reports

Commissioner Sayer commended Mr. Bill Granger for his professionalism and always what's best for the county.

Commissioner Carter echoed Commissioner Sayer's comments concerning Mr. Granger; inquired about stripping for Walter Road; FEMA grants available for Fire Department equipment; and DOR report of unclaimed property for the county.

County Administrator Partain reported the stripping company agreed to take on additional roads in the county however, funding has not been determined.

a) Poultry Ordinance Advisory Committee
