Hart County Board of Commissioners met December 13, 2022 at 6:00 p.m. at the AgriScience Center located on Bowman Highway, Hartwell Georgia.

Chairman Marshall Sayer presided with Commissioners Michael Bennett, Frankie Teasley, Jeff Brown and Joey Dorsey in attendance.

1. Prayer

Prayer was offered by Commissioner Dorsey; thanked the Board of Education and School Superintendent Jennifer Carter for the use of the facility.

2. Pledge of Allegiance

Everyone stood in observance of the Pledge of Allegiance.

3. Call to Order

Chairman Sayer called the meeting to order.

Chairman Sayer welcomed those in attendance.

7. Remarks By Invited Guests, Committees, Authorities
Jeffery Dorfman, Ph.D., Professor Agricultural and Applied Economics
University of Georgia

Professor Dorfman explained according to research in housing development growth can put an additional strain on public services, roads and school system to name a few; new growth is good only if it grows revenue faster than expenses; housing should be done for economic reasons to help protect the agricultural industry in the county as well as its rural character; one out of six jobs in the state is connected to agricultural and forestry; agriculture in Hart County is the leading industry.

If new housing were to be developed it should be close to the city where infrastructure already exist.

He also explained homes would need to be valued more than the average housing cost in the county to provide for a child's educational needs.

Several individuals in the audience spoke in opposition to additional housing development in Hart County.

County Attorney Walter Gordon reported an objection was filed for the City's annexation request with the Department of Community Affairs within the time frame required by law; as of response received December 8, 2022 DCA was unable to assemble a panel of arbitrators.
