## Hart County Board of Commissioners March 22, 2022 6:00 p.m.

Hart County Board of Commissioners met March 22, 2022 @ 6:00 p.m. at Hart County Administrative & Emergency Services Center.

Chairman Marshall Sayer presided with Commissioners Michael Bennett, Frankie Teasley and Joey Dorsey in attendance. Commissioner Ricky Carter was absent.

1. Prayer

Prayer was offered by Commissioner Bennett.

2. Pledge of Allegiance

Everyone stood in observance of the Pledge of Allegiance.

3. Called to Order

Chairman Sayer called the meeting to order and announced March 22, 2022 called meeting has been cancelled.

4. Welcome

Chairman Sayer welcomed those in attendance.

5. Approve Agenda

Commissioner Dorsey moved to approve the meeting agenda to include items 13 I) Four Corners Group – Letter of Support; m) Water & Sewer Authority Letter of Support. Commissioner Teasley provided a second to the motion. The motion carried 4-0.

County Attorney Walter Gordon explained the Board of Commissioners has no legal authority to dismiss Commissioner Carter due to his recent arrest; the issue will be handled the same way former Commissioner Oglesby was; if Commissioner Carter were indicted by the Grand Jury the District Attorney would have the power and authority to forward the indictment to the Governor's office; it will be up to the Governor's office to decide if the crime impairs his ability to be a commissioner or imposes a threat to the county's money/people.

Chairman Sayer stated Commissioner Carter did not take any action to stop the recent assault on Jack Williford; furthermore, his actions are an embarrassment to the whole county; he publicly thanked Aaron Dowell for assisting Mr. Williford; and ask for Commissioner Carter's immediate resignation.

Chairman Sayer moved to not fund Commissioner Carter to attend the ACCG Annual Conference. Commissioner Teasley provided a second to the motion. The motion carried 4-0.

Commissioners Teasley and Dorsey agreed with Chairman Sayer to ask for Commissioner Carter's resignation.

Commissioner Dorsey moved to remove Commissioner Carter from GA Mountains Regional Commission. Commissioner Teasley provided a second to the motion. The motion carried 4-0.

  - a) Final Plat Approval Lake Pointe Estates Subdivision, California Girls Land Holdings LLC, Parcel C81D 014

Commissioner Dorsey moved to approve Lake Pointe Estates Subdivision with encroachment recorded on the deed. Chairman Sayer provided a second to the motion. The motion carried 4-0.

- 13. New Business
  - a) Tax Refund Request Gregory Daniel Parcel C83A 026 003

Mr. Daniel expressed his concern for lack of guidance from Brad Goss during his visit to the Appraiser's office to file eligibility for the disabled veteran's exemption; he feels he is eligible for a tax refund for 2021 of \$1,330.56.

Chief Appraiser Patrick explained the appraisal staff is following State of Georgia guidelines; to quality for the veteran's exemption the documents would have to be approved prior to January 1, to qualify for tax year 2021.

Commissioner Bennett moved to grant Mr. Daniel's tax refund request. The motion died from lack of a second.

Commissioner Dorsey moved to deny Mr. Daniel's tax refund request. Commissioner Teasley provided a second to the motion. The motion carried 4-1 (Commissioner Bennett opposed).

b) Tax Refund Request Gregory Durkin Parcel C26B 028 001

Chief Appraiser Patrick explained Mr. Durkin's request was based on taxed for a pool; value wasn't increased due to a pool; in addition, no tax return was submitted to his office.

Commissioner Dorsey moved to deny Mr. Durkin's request for a tax refund for 2019 & 2020. Commissioner Bennett provided a second to the motion. The motion carried 4-0.

c) David Staebell Setback Variance Request Parcel Number I56D 012

Commissioner Dorsey moved to deny Mr. Staebell request for a variance. Commissioner Teasley provided a second to the motion. The motion carried 4-0.

d) Resolution in support of HB 1461

i) GSP Surplus vehicles

Commissioner Dorsey moved to purchase (4) used vehicles up to \$50,000. Commissioner Bennett provided a second to the motion. The motion carried 4-0.
