Hart County Board of Commissioners met April 23, 2019 at 6:00 p.m. at the Hart County Administrative & Emergency Services Center.

Chairman Joey Dorsey presided with Commissioners R C Oglesby, Frankie Teasley, Marshall Sayer and Commissioner Ricky Carter joined via telephone.

8. Reports By Constitutional Officers & Department Heads Lisa Evans, Senior Center Director, Update

Chairman Dorsey commended Communication Officers for their service and recognized them as a life line for EMS/Fire/Sheriff; and reported the bush hog crews are not able to keep up with the work load due to the volume of rain. Therefore, they are cutting high volume roads at this time, secondary roads will be cut later.

Ms. Strickland reported with the assistance of the Archway program 250 projects have been completed since 2009; 100 students have been involved with the process; Hart County has been chosen for 4

engineering projects; October 11 Cyber Task Force will be piloting community training and thanked the BOC for their support.

Commissioner Sayer moved to approve the MOU for Hart County's allocation of \$12,000 for FY2020. Commissioner Teasley provided a second to the motion. The motion carried 4-0.
