8. Reports By Constitutional Officers & Department Heads Wayne Patrick, Chief Appraiser's Quarterly Report

Chief Appraiser Patrick reported the tax appeal process ends Friday June 28 at 5:00 p.m.; the Appraiser's office has received 142 appeals to date; the BOA will meet July 1, 2019 to vote to turn the digest over to the Tax Commissioner; currently disputes are less than 1% of the digest.

Chairman Dorsey inquired about the real estate sales ratio study which impacts how utility companies are taxed at a lower rate when the ratio is below 40%; which impacts the Board of Education along with the

County, and what is being done to avoid the same issue next year. Appraiser Patrick responded 60% of the sales ratio study involved rural areas, most were improvements that were done without a building permit. However, since the public has been notified about the permit system there should be improvement moving forward.

Chairman Dorsey stated he wants to understand what's going on and ask the Board of Assessors to do this as well.

9. County Administrator's Report

County Administrator Terrell Partain announced the Career Coach postponed the event scheduled June 26, 2019; Solid Waste Transfer Station building will be closed June 28 through July 6 for repairs.

Chairman Dorsey thanked all Public Safety/Public Works/Power Company employees for their service during the recent storms; the 911 center was hit by lightning on June 24 and thanked everyone involved in making sure the calls were answered without an interruption in services.
