Hart County Board of Commissioners met July 22, 2025 at the Hart County Administrative and Emergency Services Center.

Chairman Marshall Sayer presided with Commissioners Michael Bennett, Frankie Teasley, Jeff Brown, and Joey Dorsey present at the meeting.

1. PRAYER

Prayer was offered by Chairman Sayer

2. PLEDGE OF ALLEGIANCE

Everyone stood in observance of the Pledge of Allegiance.

3. CALL ORDER

Chairman Sayer called the meeting to order.

4. WELCOME

Chairman Sayer welcomed those in attendance via in person, HTC and YouTube.

5. APPROVE AGENDA

Commissioner Bennett moved to approve and amend the agenda to add 13e) EMS Gator Purchase; 13f) Paynes Creek Gator Purchase; 13g) Credit for Experience Sheriff Department; 13h) Credit for Experience Sheriff Department and remove item 12e) Business License Ordinance. Commissioner Teasley provided a second. The motion carried 5-0.

8. REPORTS BY CONSTITUTIONAL OFFICERS & DEPARTMENT HEADS

Chief Appraiser Shane Hix reported that the City of Hartwell have opted into HB 581; Tax Assessment notices have been approved and will be mailed out within the next 7 days; included in the assessment notices is an insert explaining that effective 7/1/2025 home owners can now file for homestead exemption during the appeal time; Kris Dickerson and Nicole Norman are working on information for the personal property (cell tower) audit; the Digest has increased 7% - 8% from last year.

Commissioner Brown moved to approve using the prior year's millage rate for the current tax assessment notices. Chairman Sayer provided a second. The motion carried 5-0.

9. COUNTY ADMINISTRATOR'S REPORT

County Administrator, Terrell Partain reported that Lankford Road will be closed in sections tomorrow July 23 and possibly Thursday for bushhogging; that he had spoken the Archway about the UGA videography class possibly evaluating and revising the County website.

Chairman Sayer moved to approve the UGA videography class to evaluate the County's website and present changes to the Board. Commissioner Teasley provided a second. The motion carried 5-0.

a) Equine Fireworks Ordinance (to comply with HB 614)

Chairman Sayer moved to accept the 1st Reading of the Equine Fireworks Ordinance to prohibit the use or ignition of consumer fireworks within 200 yards of facilities housing equines, such as horse stables and farms. Commissioner Bennett provided a second. The motion carried 5-0.

Commissioner Bennett moved to have a barricade put in place at the end of Old Mount Hebron Road. Commissioner Dorsey provided a second. The motion carried 5-0.
