Hart County Board of Commissioners met July 9, 2024 at 6:00 p.m. at the Hart County Administrative & Emergency Services Center.

Chairman Marshall Sayer presided with Commissioners Michael Bennett, Frankie Teasley, Jeff Brown, and Joey Dorsey in attendance.

1. Prayer

Commissioner Brown offered prayer.

2. Pledge of Allegiance

3. Call to Order

Chairman Sayer called the meeting to order.

4. Welcome

Chairman Sayer welcomed all those in attendance via in person, HTC Channel 3 or YouTube.

9. County Administrator's Report June Financial Report

County Administrator Terrell Partain presented General Fund financial reports as of June 30, 2024; reported Whitworth Work Crews are picking up litter on county rights-of-way; and the roof project for the Fire Department Administrative Building is complete.

Administrator Partain also reported the county has an estimated \$7,705,993.00 unaudited funds from SPLOST V for county roads. He pointed out the cost per mile for paving is \$130,000.00 and more for milling. He also explained some of the access SPLOST funds have accumulated over the past sixteen months.

Commissioner Dorsey responded that the county is sitting on an estimated ten years of road SPLOST funds.

Commissioner Teasley stated the county has enough SPLOST funds for roads for a couple of years and could then put TSPLOST on the ballot.

Chairman Sayer stated striping roads is a concern therefore, the county should also utilize funds for striping projects also.

Commissioner Brown pointed out the longer the county waits for road projects the cost continues to rise.

Matt Denton representing the Property Owners Association and the Republican Party voiced his opinion on SPLOST V fund balance; he was not in favor of putting TSPLOST on the ballot with the current fund balance available.

Tracy McCord representing Grace Covenant Church the use of the courthouse grounds for a call to pray for the community and leaders.

Chairman Sayer moved to grant Grace Covenant Church permission for use of the courthouse grounds (amphitheater area). Commissioner Brown provided a second to the motion. The motion carried 5-0.

Chairman Sayer announced the Sheriff's election is over, Chris Carroll will take office January 1, 2025.
